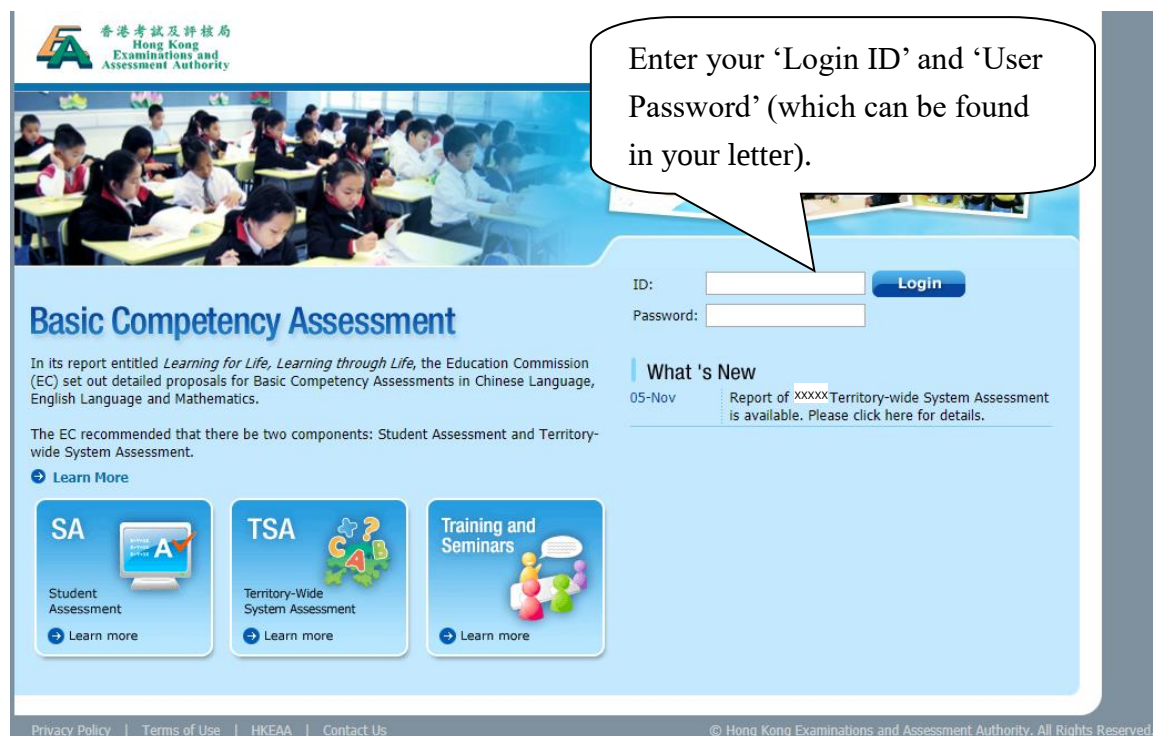


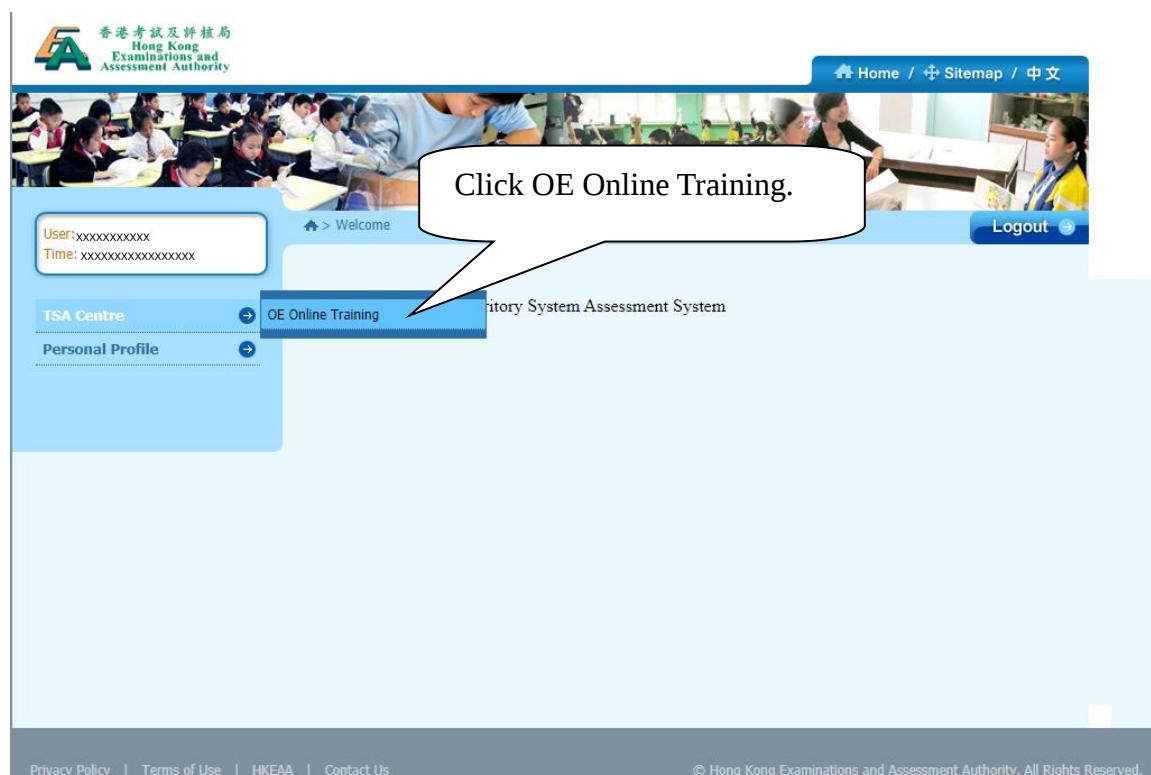

1. Go to <http://www.bca.hkeaa.edu.hk/> Enter your 'Login ID and 'User Password'.

With effect from 1 July 2004, private schools offering non-formal curriculum is exempt from certain requirements of the provisions of the Education Ordinance and Education Regulations relating to fees, employment of teachers, teachers' qualifications, principals, holidays and hours of instruction subject to their compliance with conditions specified in the Education (Exemption) (Private Schools Offering Non-formal Curriculum) Order. For the avoidance of doubt, 'tutorial school' may come under different names such as 'tutorial school', 'tutorial centre', 'education centre', 'college', etc.
- Ⓢ 'Members of immediate family' refers to spouse, children, parents, brothers and sisters.
- Ⓢ 'Persons with whom I have close personal ties' refers to relatives outside my immediate family / close friends with whom I am in regular contact.

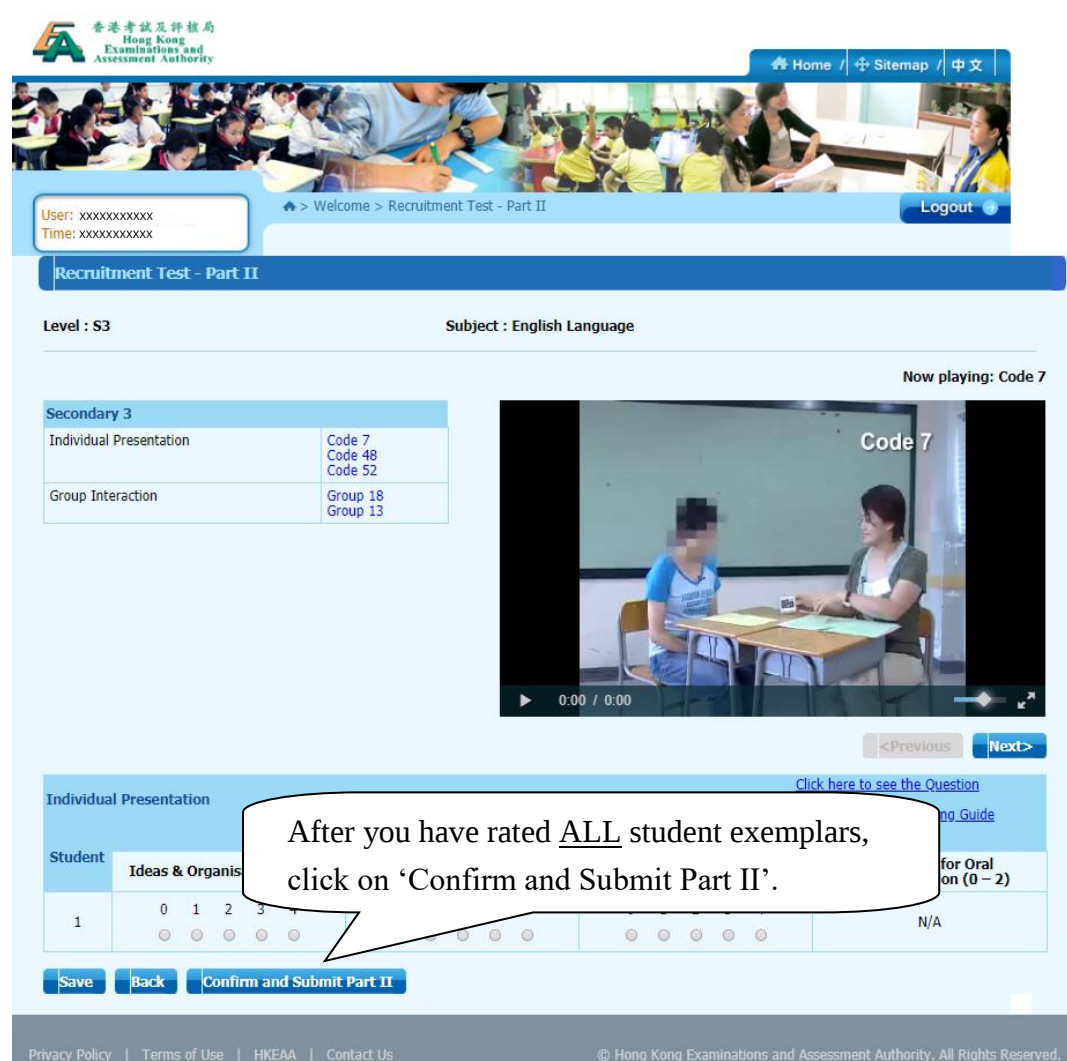

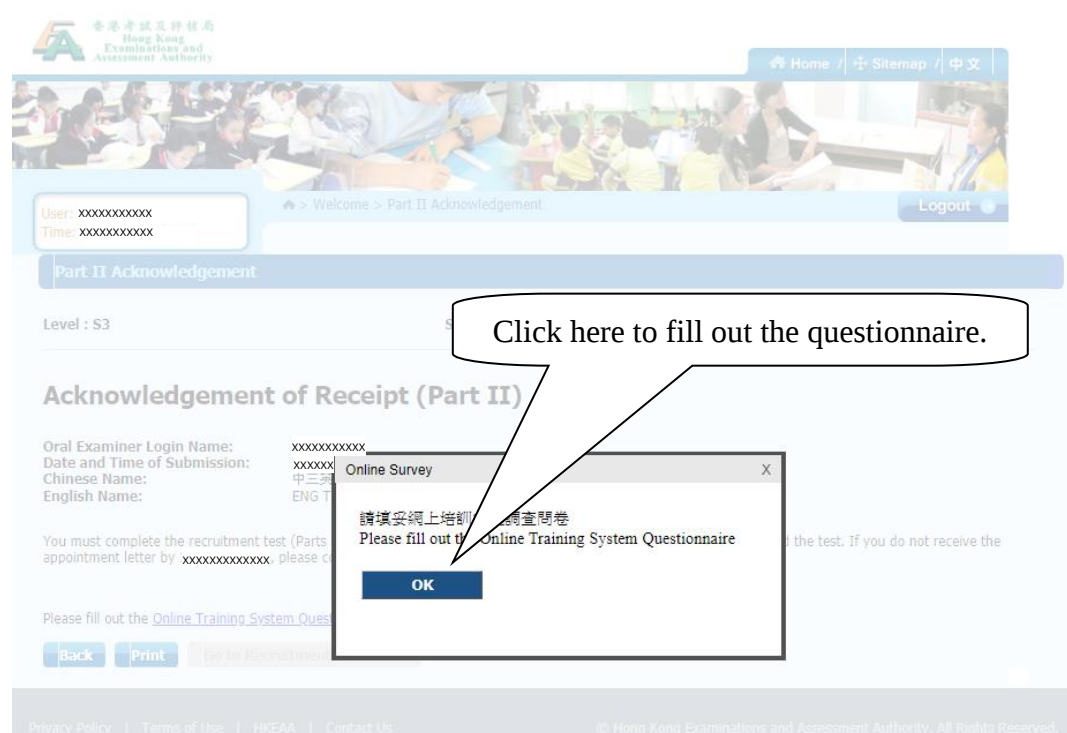
